1. Executive summary / introduction

The Dendrobium Community Consultative Committee (DCCC) continued to operate as a responsible and considerate representative group for the communities close by the Dendrobium Mine at Mt Kembla, NSW.

2. CCC activities over last 12 months:

- The DCCC met on six occasions at approximately two monthly intervals.
- Meetings were held at the Colliery and were generally well attended. All committee
 members maintained a good attendance record. One committee member had an approved
 leave of absence for several months.
- Site visits were requested into the Sydney water catchment under which long-wall mining activity occurs. While site visits did occur, several were cancelled or postponed due to inclement weather. Topics of interest during site visits included the health of swamps and flora and fauna within the catchment.
- The DCCC is an effective community consultative committee. Both committee members and the proponent, South32/Illawarra Metallurgical Coal, take the committees activities and responsibilities seriously. Difficult questions can be, and are, put to the proponent from time to time and generally they are taken seriously and are addressed openly and honestly.
- The retirement of very long-term committee members Vivien Twyford and Alex Beccari are noted. Both served on the DCCC for in excess of 20 years and as local residents of Mt Kembla brought a sincere and responsible concern for the health and well-bring of the community. Viv's and Alex's wisdom and balanced participation will be missed.
