1. Executive summary / introduction

The Russell Vale Community Consultative Committee (RVCCC) continued to operate as a representative group for the communities close by the Russell Vale Colliery in the northern suburbs of Wollongong, NSW.

2. CCC activities over last 12 months:

- The RVCCC met on three occasions at approximately three-month intervals. The February 2024 meeting was cancelled at short notice following unexpected changes to Wollongong Resources business circumstances. The meeting was not re-scheduled.
- Meetings were held at the Colliery and were generally well attended. Most committee members maintained a good attendance record.
- The RVCCC is only moderately successful in establishing and maintaining good working relationships between the proponent and committee members representing their communities. There are encouraging signs the incoming chairperson and new company representative at CCC meetings will foster more trust between the parties.
- Two new community representatives were recruited to the RVCCC during the FY 23-24 following two resignations.
