1. Executive Summary

The Moolarben Coal Mine is an open cut and underground coal mine located about 40 kilometres northeast of Mudgee in the Mid-Western Regional Council local government area.

The site comprises of four approved open cut mining areas, three approved underground mining areas and other mining related infrastructure.

The mine commenced operations in 2008 and has received modified consents from that time.

A Community Consultative Committee (CCC) operates in accordance with the Department of Planning & Environment's Community Consultative Committee Guidelines for State Significant Development. The committee was established following the mine's approval and the membership consists of:

- Four local community representatives
- One Mid Western Regional Council delegate (and alternate)
- One stakeholder group (Mudgee Business Chamber)
- One local aboriginal land council delegate
- Three company representatives; and
- One Independent Chairperson.

The meetings are held quarterly March, June, September & November and attendees receive a comprehensive presentation from the proponent. Topics of discussion during the report period included:

The CCC is an effective communication forum between the community, the Council and the company. It functions well and accordingly, fulfils its objectives under the Department's guidelines.

2. CCC activities over last 12 months

- The CCC meet quarterly.
- Attendance at the meetings is good, with the occasional apology due to competing commitments.
- Briefing on the Underground Mine 2 modification. (Stage 2 Project Approval updated to incorporate the modification.)
- Briefing on the Open Cut 3 Extension Proposed Amended Project
- The CCC received a presentation by the Independent Chairperson on the Department of Planning's revised guidelines for SSD CCCs; outlining the changes and providing an opportunity to reinforce the objectives of the CCC and role of members. The members of the CCC have developed a specific Terms of Reference for this committee as well as completed the necessary governance forms (Pecuniary Interest Declarations and Code of Conduct), which will be reviewed annually.
- There were no joint CCC's held in the area.

- Continued updates on the progress of Open Cut 3 Extension application currently before DPHI.

Review of Effectiveness of the CCC

In accordance with the revised CCC guidelines, it is deemed that the CCC operates effectively. The proponent provides comprehensive presentations, ongoing notifications, timely responses to requests and completion of action items. There have been no concerns raised by CCC members.

To the best of my knowledge, there are no outstanding or emerging issues that have not been addressed.

Note: At the Q1 meeting of the MCO CCC, the Independent Chair advised that she had informed the Department of Planning that she was stepping down, thereby handing back the CCC to DPHI. In July 2024, DPHI appointed a replacement Chairperson from its Talent Pool.
