1. Executive Summary

Sapphire Wind Farm Pty Ltd is located in the Northern Tablelands region, 18 kms west of Glen Innes and 28 km east of Inverell, in the Glen Innes Severn and Inverell Shire local government areas.

The project was originally approved on 26/6/13 for 159 wind turbines, and associated infrastructure, however, following a modification application was reduced to 109 turbines and approved on 30 June 2016.

The proponent, CWP Renewables Pty Ltd, consulted with the community from the commencement of its preparation for their development application in 2013. First meeting approximately once per year, the CCC now meets on a quarterly basis, alternatively between Glen Innes and Inverell venues.

In late 2022 the project was purchased by Squadron Energy.

The Community Consultative Committee (CCC) operates in accordance with the Department of Planning's revised Community Consultative Committee Guidelines for State Significant Development. The committee's membership consists of:

- Two local community representatives
- One Glen Innes Severn Council delegate
- One Inverell Shire Council delegate
- Two stakeholder group delegate (representing both the Inverell Business Chamber & Church Communities Australia)
- One stakeholder group representative (Business in Glen)
- A guest from Department of Regional NSW North West
- One host landholder; and
- One Independent Chairperson.

2. CCC activities over last 12 months

Over the past 12 months, the CCC met in June 2023 and June 2024 with members receiving presentations and updates from the proponent's representatives on:

- The operation and output from the project
- Management Plan Updates
- Environmental monitoring
- Annual and ongoing maintenance of the wind turbines, site roads and weed management
- Continued Improvement Modifications (ongoing)
- Bird and Bat Management (second phase)
- Power generation budgets
- Sapphire Solar Farm
- Community Enhancement Fund Program

 The CCC received a presentation by the Independent Chairperson on the Department of Planning's revised guidelines for SSD CCCs; outlining the changes and providing an opportunity to reinforce the objectives of the CCC and role of members. The members of the CCC have developed a specific Terms of Reference for this committee as well as completed the necessary governance forms (Pecuniary Interest Declarations and Code of Conduct), which will be reviewed annually.

Review of Effectiveness of the CCC

In accordance with the revised CCC guidelines, it is deemed that the CCC operates effectively. The proponent provides comprehensive presentations, ongoing notifications, timely responses to requests and completion of action items. There have been no concerns raised by CCC members.

As the project is now in its operational phase and therefore minimal concerns from the community, accordingly, CCC members agreed to reduce meetings to 1 per year.

The CCC is a successful forum between the community, the Council and the company. It fulfils its objectives under the Department's guidelines and whilst attendance has been low, it is consistent.

There were no joint CCC's held in the region.

3. Key issues

The proponent will continue to provide CCC members with a presentation on the operation of the Sapphire Wind Farm, including output, maintenance and environmental monitoring.

To the best of my knowledge, there are no outstanding or emerging issues that have not been addressed.
